Bidders submitting their bid hard copy at the office of Bulingtar rural municipality, should deposit the cost (NRs 3000) of bidding document in the Project's Rajaswo (revenue) account as specified below and the copy of the Bank deposit voucher shall be submitted by the bidder at the time of submission of the bids. - Hard copy bids must be submitted to the Bulingtar rural municipality, Office of Rural Municipal Executive, Bulingtar on or before 12.00 noon on 2078/08/08 (24th Nov 2021). Bids received after this deadline will be rejected.
- 5. The bids will be **opened** in the presence of Bidders' representatives who choose to attend at **2 pm on 24th**, **Nov 2021** at the office of Bulingtar Rural Municipality office of Rural Municipal executive, Bulingtar. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security, amounting to a minimum of **NRs. 78,000.00**, which shall be valid for 30 days beyond the validity period of the bid.
- 6. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 7. All the supplies should have at least 18 month of expiry date remaining at the time of delivery.
- 8. If any particular Medicine/Surgical Items have half-life less than 18 month, then those items will be received.
- 9. All items, as applicable, should follow WHO-GMP guidelines.
- 10. All Medicines should be registered and approved by DDA Nepal.
