Bidders are required to follow the electronic bid submission procedure as specified in e-GP System Operating Guideline 2073 and User manuals issued by PPMO which are available in e-GP system.
7. Online bids shall be opened in the presence of Bidders representatives who choose to attend on specified time above at the office of Bulintar Rural Municipality, Nawalparasi-East Nepal.
8. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
