Invitation for Bids for the Construction of Pudi Thambesi Water Supply Project of Ward no 1

1. Bulingtar Rural Municipality has allocated funds towards the cost of **Construction of Pudi Thambesi Water Supply Project of Ward no 1** and intends to apply part of the funds to cover eligible payments under the Contract for **Bul/NCB/Works/02/2077/078**. Bidding is open to all eligible as per Section V of bidding document.
2. Bulingtar Rural Municipality electronic bids from eligible bidders for the **Construction of Pudi Thambesi Water Supply Project of Ward no 1** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.
Only eligible bidders with the following key qualifications should participate in this bidding:
 - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs 40,000,000.00**
 - Minimum Work experience of similar size and nature: at least **1 (one)** Contracts within the last **10 (ten)** years, each with a value of at least **NRs 22,000,000**
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
4. Bidders, submitting their bid electronically, should deposit the cost of bidding document in Office's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.

6. Pre-bid meeting shall be held at the Office of The Rural Municipal Executive, Bulingtar Rural Municipality, Bulingtar Nawalparasi(East) at 22-10-2020 13:00 Hrs
7. Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 Hrs on 04-11-2020.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 04-11-2020, 13:00 Hrs at the Office of The Rural Municipal Executive, Bulingtar Rural Municipality, Bulingtar Nawalparasi(East). Bids must be valid for a period of 90 days after bid opening and must be accompanied by a scanned copy of the bid security in pdf format, amounting to a minimum of NRs. 620,000.00 which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.

10. The employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.

11. Any provisions which are not mentioned in this notice will be consistent with PPA 2063, PPR 2064 and other prevailing Nepalese Laws.
